Liability Limitation IAA Test Drives and IAA Shuttle Bus Within the Scope of IAA TRANSPORTATION

The VDA accepts no liability whatsoever for damage to property or personal injury suffered by the exhibitor as a result of a technical defect of the vehicle and/or misconduct on the part of the visitor driving the vehicle or the driver provided and instructed by the exhibitor or the driver of a third-party agency during the test and shuttle runs on the IAA TRANSPORTATION exhibition grounds and during the city tour, overland tour or on the motorway. The VDA merely provides exhibitors with the exhibition space on the exhibition grounds for the purpose of carrying out the test drives on their own responsibility. In the event that the participating visitor (third party) suffers damage due to a technical defect of the vehicle and/or due to misconduct on the part of the visitor driving the vehicle or the driver provided and instructed by the exhibitor or the driver of a third-party agency, the exhibitor undertakes to indemnify the VDA against claims of any legal nature by the third party. Furthermore, the VDA must be reimbursed for all legal defense costs incurred in this connection. In addition, the applicable road traffic regulations must be complied with. Besides, the exhibition conditions apply.

As in previous years, we will not provide a central registration for visitors interested in Test Drives. Establishing contacts with customers at the approach and departure points and handling (incl. insurance, checking driver's licenses, fitness to drive, co-travelcards etc.) are done at your own stand, and test drives are performed under your own responsibility. As exhibitor it is up to you whether visitors drive themselves or simply take part in the Test Drives as passenger.

Visitors participating in Test Drives must sign a waiver of liability towards the exhibitor (to be provided by the exhibitor, please send us your form before the IAA by 08/16/2024 at the latest) and proof of a driver's license (if drivers are driving themselves). Exhibitors are obliged to verify whether persons are in a position and condition to drive the vehicle themselves. During the Test Drives, a person familiar with the vehicle must be present in the driver's cab. We would like to point out that the test vehicles used must have respective insurance cover as well as road approval.
